Dear Justice Carpio,

This has reference to your invitation for me to grace and give commentaries to the panel of 1Sambayan's *Town Hall Meeting on National Security and Foreign Policy for* 2022 on 19 June 2021 (Annex "A") and to the prior request of the party, through Ms. Roselyn Salagan, for my 30-seconder video and one-pager profile, supposedly as one of the Presidential nominees under consideration of 1Sambayan (Annexes "B" and "C").

The agenda of the event to provide a forum of ideas for the analysis of our current policies presents a sound objective, especially in addressing our challenges in the new normal and steering our nation on course for development. It shares my call for a more discerning and rational leadership, a departure from entertainment politics that I have emphatically denounced in the long span of my public service.

Notwithstanding the many insights I wish to impart as one of the reactors of the forum, it is my submission that my participation will be construed as a lack of propriety on my end in light of your prior pronouncements suggesting that my representation will be a "stumbling block" on your political endorsements.

Allow me to express with candor that after personally seeing your interview with Karen Davila on ANC's Headstart dated 24 March 2021, I have been under the

impression that the 1Sambayan Coalition has effectively precluded any possible association with this representation, since you made it clear, as its lead convenor, that it would be 'inconsistent' and 'incongruous' for the group to endorse, let alone be identified with somebody who is one of the authors and the principal sponsor of the very piece of legislation that most of its members, if not all, have been questioning before the Supreme Court.

While you have explicitly and repeatedly made a remark during the interview that you have 'no problem' with me running again as Senator in the upcoming national elections, I could not possibly reconcile how such would be the case if it has been publicly disclosed by the former Associate Justice that his misgivings are anchored on this representation's stand in earnestly sponsoring a measure in the exercise of my sworn duty as one of the elected lawmakers of the land.

Hence, as any self-respecting public servant would do, it is in my humble position to take it upon myself to graciously decline your invitation in honor of my personal and political convictions that I have consistently and unwaveringly adhered to, and in consideration of the supposed 'inconsistency' and 'incongruence' that these may entail to your political endeavors.

To this end, I still wish to express my gratitude to 1Sambayan for considering my participation in your event and my representation as one of your Presidential nominees.

I earnestly hope that the town hall meeting will be an opportune event to advance rational discourse and open engagement on crucial topics affecting our country.
